- 1. Breeder is selling African Pygmy Hedgehog as a PET ONLY.
- 2. The buyer accepts the responsibly of caring for this hedgehog and providing properly for its welfare. The buyer agrees to follow breeder instructions on care, housing, diet, treatment and health.
- **3.** Buyer understands that because hedgehogs shed quills throughout their lives, breeder cannot guarantee the color of the animal nor guarantee the animal will not snowflake.
- **4.** The buyer agrees to provide companionship for this hedgehog, never leaving it without human attention for too long.
- 5. The buyer agrees to provide generous amounts of exercise for this hedgehog and provide it toys.
- 6. The buyer agrees to never use rabbit, ferret or rodent water bottles as they are not compatible with hedgehogs and can cause permanent and often painful oral damage.
- 7. Buyer agrees to be using a poultry drinking bottle or drinking bowl within 30 days of receiving hedgehog.
- **8.** The buyer agrees that this hedgehog will never be sold, leased, or given away to any pet shop, animal shelter, research laboratory, or similar facility.
- 9. Buyer is contracted to provide a lifetime home for this hedgehog.

- 10. Buyer will contact the breeder if the buyer is unable to keep the hedgehog.
- **11.** Buyer agrees that if they are no longer able care for the animal, the hedgehog purchased must be returned to breeder and no other home or other facility without a refund of purchase price.
- 12. The buyer agrees if any of the terms above or below are disregarded, that the breeder may reclaim this hedgehog without a refund of the purchase price. The buyer agrees to pay all court costs, legal fees and a fine of \$500.00 if this contract is litigated. Venue is in the state of Illinois, McLean county.
- **13.** Buyer agrees that if for any reason the hedgehog is relinquished, abandoned, found outside, placed in animal shelter, veterinary office or any other type of facility, the buyer forfeits any rights of ownership to reclaim the hedgehog, and the seller may reclaim the animal. Only at the seller's discretion will the hedgehog be returned to buyer.
- 14. Buyer agrees that hedgehog is **PET ONLY** and will not be bred or leased without seller's consent.
